Drawing Requirements. The theme of the Drawing (the "Art Contest Theme") should relate to "What I Love About Orlando" Drawings with depictions of trademarked symbols will not be considered. Drawing must be the student's original hand drawn-creation and may not be traced or copied from photographs or other artists' published works. Photographs taken by the student may be used as references in the development of the design. Computers or other mechanical devices may not be used in creating the Drawing. Air brush is permitted. Please DO NOT STAPLE OR FOLD the completed Drawing. All Drawings must be the sole, original work and exclusive property of the submitting contestant. Sponsor and/or the judges. Drawings must not have been entered in any other competitions or have won previous awards or competitions.

A panel of judges appointed by Sponsors will judge the Art Contest. The Art Contest judges will be in two rounds, according to four (4) grade brackets: K - Grade 2; Grade 3 - Grade 5; Grade 6 - Grade 8; and Grade 9 - Grade 12. Four (4) First Prizes will be awarded (one First Prize in each Grade Bracket). First Prize consists of \$100. Four (4) Second Prizes will be awarded (one Second Prize in each Grade Bracket). Second Prize consists of \$50. Four (4) Third Prizes will be awarded (one Third Prize in each Grade Bracket). Third Prize consists of \$25

Winners will be notified by June 30, 2020. All decisions are based on the soul discretion of the sponsors and it's interpretation of these social rules and are final and binding in all respects.
